1.2 Background

The Company announced on 28 June 2023 that it had received binding commitments from sophisticated, professional, and institutional investors (**Investors**) for a placement to raise \$3.55 million, through the issue of 39,444,454 Shares at an issue price of \$0.09 per Share (**Placement**). The Company also agreed to issue the Investors one (1) New Option for every (2) Shares subscribed for by Investors under the Placement, exercisable at \$0.15 each on or before 30 June 2024.

The Company issued:

- (a) 7,082,388 Shares under ASX Listing Rule 7.1; and
- (b) 32,362,066 Shares under ASX Listing Rule 7.1A,

to the Investors pursuant to the Placement on 6 July 2023.

In addition to the \$3.55 million raised from unrelated parties, the Company sought shareholder approval at a general meeting on 11 August 2023 (**General Meeting**) for Directors, Christopher Cairns, Jennifer Murphy, Peter Ironside and Amanda Sparks (together, the **Participating Directors**) to participate in the Placement on the same terms as the Investors. Shareholders approved the Participating Directors participation in the Placement at the General Meeting on the following terms:

- (a) Christopher Cairns: 111,111 Shares and 55,555 New Options;
- (b) Jennifer Murphy: 111,111 Shares and 55,555 New Options;
- (c) Peter Ironside: 555,556 Shares and 277,778 New Options; and
- (d) Amanda Sparks: 333,333 Shares and 166,666 New Options.

The Company also obtained Shareholder approval pursuant to ASX Listing Rule 7.1 at the General Meeting for the issue of the New Options to the Investors under the Placement Options Offer and to the Lead Manager under the Lead Manager Options Offer.

2. DETAILS OF THE OFFERS

3.1 Purpose of the Offers

The purpose of the Placement Options Offer is to offer Investors and Participating Directors who participated in the Placement one (1) free New Option for every two (2) Shares subscribed for under the Placement.

The purpose of the Lead Manager Options Offer is to satisfy the Company's agreement to issue 4,000,000 New Options to the Lead Manager (or its nominee).

In addition to the above purposes, the Offers are being made under this Prospectus to remove any trading restrictions attaching to the New Options and any Shares issued on exercise of the New Options. The Company confirms that:

Accordingly, the immediate financial effect of the Offers will be to reduce the Company's existing cash reserves by \$276,172.

4. RIGHTS ATTACHING TO SECURITIES

4.1 Terms of the New Options

(a) Entitlement

Each Option entitles the holder to subscribe for one (1) fully paid ordinary share (**Share**) in the Company upon exercise of the Option.

(b) Exercise Price

Subject to paragraph (i), the amount payable upon exercise of each Option will be \$0.15 (Exercise Price).

(c) Expiry Date

Each Option will expire at 5:00pm (AWST) on 30 June 2024 (**Expiry Date**). An Option not exercised before the Expiry Date will automatically lapse on the Expiry Date.

(d) Exercise Period

The Options are exercisable at any time on or prior to the Expiry Date (Exercise Period).

(e) Notice of Exercise

The Options may be exercised during the Exercise Period by notice in writing to the Company in the manner specified on the Option exercise notice (**Notice of Exercise**) and payment of the Exercise Price for each Option being exercised in Australian currency by electronic funds transfer or other means of payment acceptable to the Company.

(f) Exercise Date

Full details of the rights and liabilities attaching to Shares are set out in the Constitution, a copy of which is available for inspection at the Company's registered office during normal business hours.

(a) General meetings

Shareholders are entitled to be present in person, or by proxy, attorney or representative to attend and vote at general meetings of the Company.

Shareholders may requisition meetings in accordance with section 249D of the Corporations Act and the Constitution of the Company.

(b) Voting rights

Subject to any rights or restrictions for the time being attached to any class or classes of shares, at general meetings of shareholders or classes of shareholders:

- (i) each Shareholder entitled to vote may vote in person or by proxy, attorney or representative;
- (ii) on a show of hands, every person present who is a Shareholder or a proxy, attorney or representative of a Shareholder has one vote; and
- (iii) on a poll, every person present who is a Shareholder or a proxy, attorney or representative of a Shareholder shall, in respect of each fully paid Share held by him, or in respect of which he is appointed a proxy, attorney or representative, have one vote for each Share held, but in respect of partly paid shares shall have such number of votes as bears the same proportion to the total of such Shares registered in the Shareholder's name as the amount paid (not credited) bears to the total amounts paid and payable (excluding amounts credited).

(c) **Dividend rights**

Subject to the rights of any preference Shareholders and to the rights of the holders of any shares created or raised under any special arrangement as to dividend, the Directors may from time to time declare a dividend to be paid to the Shareholders entitled to the dividend which shall be payable on all Shares according to the proportion that the amount paid (not credited) is of the total amounts paid and payable (excluding amounts credited) in respect of such Shares.

The Directors may from time to time pay to the Shareholders any interim dividends as they may determine. No dividend shall carry interest as against the Company. The Directors may set aside out of the profits of the Company any amounts that they may determine as reserves, to be applied at the discretion of the Directors, for any purpose for which the profits of the Company may be properly applied.

Subject to the ASX Listing Rules and the Corporations Act, the Company may, by resolution of the Directors, implement a dividend reinvestment plan on such terms and conditions as the Directors think fit and which provides for any dividend which the Directors may declare from time to time payable on Shares which are participating Shares in the dividend reinvestment plan, less any amount which the Company shall either pursuant to the Constitution or any law be entitled or obliged to retain, be applied by the Company to the payment of the subscription price of Shares.

(d) Winding-up

If the Company is wound up, the liquidator may, with the authority of a special resolution, divide among the Shareholders in kind the whole or any part of the property of the Company, and may for that purpose set such value as he considers fair upon any property to be so divided, and may determine how the division is to be carried out as between the Shareholders or different classes of Shareholders.

The liquidator may, with the authority of a special resolution, vest the whole or any part of any such property in trustees upon such trusts for the benefit of the contributories as the liquidator thinks fit, but so that no Shareholder is compelled to accept any shares or other securities in respect of which there is any liability.

(e) Shareholder liability

(g) Future increase in capital

(i) Alteration of Constitution
